22.8.2 Release Notes

NOTE:

These release notes include notable fixes or updates in the stated products. If no notes are shown for a product, there are no notable changes for that product.

Change

- Project-level custom lists now show in drop-down list fields when there are active organization-level lists.
- New issue IDs are now assigned correctly when using dynamic issue import with new issue workflow enabled.
- During reimport, cost items that were deleted in Control are now marked Deleted in Change and Contract.
- The Pricing calculation script now runs for all expected records.
- Deleting a material markup from the project settings now works correctly.
- Change now correctly brings in the default selected vendor when a cost code is assigned to only one contract.

Compliance

- The Compliance mobile application has been updated to fix a last sync date issue and no longer crashes.
- User permissions have been updated to correct a No Modules Available pop-up in Compliance mobile and now you see all available modules in the mobile application.
- Supporting documents are now working and downloading properly in Compliance.
- Role deletion is now permitted from Role settings if that role is not associated with any Active Orgs on user assignments.
- The status setting associated with the MAP events has been updated and Event IDs are properly displaying as MAP Complete instead of Pending.
- The date time format is now working properly after a parsing issue was corrected.
- The Future assignment code base has been updated to include newly created suite projects which corrects a break in the fulfillment of Future promises in the Org Unit.
- The Save function is now working properly when changing the Reported/Responsible party in the To do list.
- When printing from Compliance Event Log page or Compliance Form, the Report Name is now properly sending and is not empty.
- Additional checks have been put in place to correct the Project Engineer Approval function being unresponsive.
- In the Templates Manager, Future children can now properly be removed or de-selected.
- Imported translations are now showing and imports for large templates are working properly.

Contract

- The Last Month End now correctly shows as the last date of the previous month.
- The Quantity claimed (to date) and Value claimed (to date) now show correctly when using the Claim multiple function.
- Edited custom fields label and value now display correctly in the SOV.
- The Save button in the Edit schedule item dialog box now works correctly when you change the unit price from zero.
- The edit contract permission now works consistently when adding line items.
- Column names with custom labels are now shown correctly in the Contract Back charge column chooser.
- Unsaved views in the Bid package register no longer revert to the enterprise view while you are working. Updating a newly saved view also works correctly.
- The WBS Phase code now imports correctly when bulk importing contract line items.
- The default currency is now used when no currency is selected so that contract line items can load correctly.
- All four settings in the contract Project settings > Contract > Configuration were changed to the "Edit contract settings" permission so that users with the Project Admin role can make changes to the configuration settings.
- The vertical form for Overdelivery tolerance was updated to read and update the overdelivery tolerance from edits made in the line item grid.
- When the reverse accrual is edited and saved, the accrual total is now saved correctly.
- The Claimed Date and Claimed on field values are now populating correctly.
- The records for InvoiceReceipt table are now saved if the SourceSystemInvoiceNumber or VendorInvoiceReference or Amount are either null or empty.
- When importing the schedule of values, only the Excel spreadsheet rows with the Hide in Plan and Progress field set to Yes are uploaded and saved.
- Already available columns for the search are properly disabled and now show the correct data.

Control

Updated 10-OCT-2022

- The code was updated to avoid time outs on the revise of an approved change order.
- Capital letters now show correctly in the Discipline dropdown in Control.
- A filter applied to the audit log is no longer causing an error and now the page loads correctly.
- For Excel and CSV imports, the Allow as-built modifications are now importing correctly.
- When performing a Copy/Insert on cost items, the creation of the new copied cost items is now correctly saving the UoM, and the sync completes successfully.
- The Current estimate cost category breakdown is now matching the Total value in the data block.
- The LEI calculation and tooltip are no longer mismatching.
- Quantities in batches greater than one now sync and show correctly from Design to Control.
- Contract forecast method will now include or exclude taxes in Contract tax settings.
- The scheduled syncs are no longer being removed from the settings.
- The project administrators now have access to the Project Library.
- The Excel Import process is no longer failing.
- The code was updated to reduce risk of data being left from previous syncs. The CBS sync now progresses successfully.

- When you modify the quantity equipment resources, the remaining equipment resources hours are now calculating correctly.
- The CBS sync now progresses successfully after the code was updated so that new created cost items have all the necessary data.
- The code was updated to not drop the connection when the Actuals sync is in progress. The Actuals sync now completes successfully.

Explore

- The code has been updated and now the Advanced Work Packaging dashboard refreshes and shows as expected.

Plan

- In Quantity Tracking, changing UOM on new components via Import is now working correctly.
- In Work Packaging, the click and drag function to select text within a work sequence is now properly working.
- In Quantity Tracking, page loading is now properly working after changes in the permission checks were made.
- When creating a daily plan from an IWP, all cost items are now being considered when selecting a record and not just those that are checked in the checkbox (left panel).
- The column chooser from the work planning screens is now loading correctly.

Platform

Updated 10-OCT-2022

- The File Storage download dialog box count indicator has been fixed to correctly show the number of documents selected.
- The code has been modified to allow a resource to have a 0 value for the total cost when a project is imported.
- The code has been fixed to retain mapping in cache for the common projects between Document accounts.
- The code has been updated and now you are able to edit Billing Classes when the Time and Material toggle is set to False.

Progress

- In Progress Mobile, the Compliance app no longer opens to the login page, but instead opens correctly to the corresponding project.
- In Progress mobile, the Component title text is now visible in Quantity screen.
- Timecards are no longer being deleted and duplicate timecards are no longer found in Timecenter after moving the daily plan from approved to final processing complete.
- In Time Center, adding multiple records is no longer causing duplicates. Now, the duplicates are ignored, and the more than 24 hours errors and warnings are triggered correctly.
- In the Time Center grid, a Labor Cost type error message is no longer triggered for a valid Cost type value upon submitting the weekly time sheet.

Report

- In Completions reporting, truncation has been corrected by extending the length of the Resolution Notes field in the Tracked Issue table.
- The code was updated to set subsequent steps status as blank instead of In approval in the Contract Workflow table after a step is recalled.
- The logic was modified to correctly calculate the total number of contracts showing in the Contract dashboard.
- The sort order in the Change Order Summary report has been modified to show change orders in sequential order.
- The Compliance Quality Forms report was redeployed to find forms when only Blanks is removed from Event Title parameter.
- The Discipline filter code has been fixed to correct the error when filtering on the package status in the Procurement Status report.
- The sign-in logic has been updated to clear hours in the Employee on Site with Hours report.
