These release notes include notable fixes or updates in the stated products. If no notes are shown for a product, there are no notable changes for that product.

Change

- Users can import cost items with blank values and Billing rate markup will be calculated on import, displayed in the Cost item pricing grid, and slide out.

Completions

- The sort by Status option now sorts correctly on the Inspection & Test Plans page.
- You can now access the Tasks tab in Template Manager without having Edit header template permission.
- The applications SSO domain configuration was updated and now the integration with InEight Document works successfully.

Compliance

- The SQC mobile application has been updated and now when you launch reports or forms that have copied sections, they open successfully.
- The modified date/time values now show in reports when text values are updated.

Contract

- Negative amounts will now be shown in parentheses in VCO.
- Template number formatting is no longer overriding InEight formatted fields.

Control

- There is no longer a delay in pushing a project from Estimate SaaS to Control - bimdesigns.
- Xer Import type can now be correctly set.
- The pushed billed revenue JSON file is no longer empty and now correctly includes the billed quantity.
- The Custom cost categories labor is now showing in the UI.
- There are no longer issues with Japanese characters being replaced with question marks on Second Import.
- Increased the size of the number column length in the Change Order table to 200.
- A scrolling issue has been resolved for the Find functionality, Create new cost item, and Copy cost item fields.
- A column labeled "Hide in Concur" was previously displayed in the data block. This has now been removed.
- The Excel import to the CBS workspace no longer has issues with the next button being inactive.
- The Adjusted CB Cost values no longer disappear in the Change register.

Plan

- IWP records are no longer duplicated in single packages. Completed work package percentages are also displayed properly.
- WBS QTY Complete % calculation is now calculated correctly.
- InEight Plan-InEight control percent complete now matches percent complete in quantity tracking.

Platform

- Permissions were removed to allow thumbnails of images. No longer see broken image thumbnails on the Project Home.

Progress

- No longer allowing claim quantity if component quantity is 0, if there are existing claims with 0 quantity, users will be alerted.
- Added approved claiming step, to solve an issue with Install Date from DailyPlan quantity claim overriding Install Date records in quantity tracking.
- Claiming negative quantities is now possible in Progress web.
- Pending changes now sync before making daily initial sync.
- You can now submit vacation on timesheets without task IDs in Progress mobile.
- Copying the allowance record has been adjusted to fetch from the employee master.
- Query builder update for timecards that have a billing class with a hyphen no longer showing errors when the 'Does not contain' filter is selected.
- Newly created and copied daily plan records are now showing in the Global time center.
- Integrated weekly timesheet records are now displaying the correct date in the global time center grid.
- Timecards are no longer displaying in the Global time center after daily plans are deleted from the Execution and Awaiting approval states.
